

**SPECIAL PROCEEDINGS OF THE  
TERREBONNE PARISH SCHOOL BOARD**

**NOVEMBER 15, 2022 – 5:00 P.M.**

The Terrebonne Parish School Board met today at 5:00 P.M. in **special session** at its regular meeting place, the Terrebonne Parish School Board Office, 201 Stadium Drive, Houma, Louisiana, with Mr. Gregory Harding, President, presiding, and the following members present: Dr. MayBelle N. Trahan, Vice President; Mr. Matthew J. Ford, Mrs. Debi Benoit, Mrs. Stacy V. Solet, Mr. Clyde F. Hamner, Mr. Roger Dale DeHart, and Mr. Dane Voisin.

ABSENT: Mr. Michael T. LaGarde

Mrs. Solet led the Board and audience in the invocation and Pledge of Allegiance to the Flag.

Motion of Mr. DeHart, seconded by Mr. Ford, unanimously carried, the Board approved the minutes of School Board Meeting of October 4, 2022, as recorded.

Motion of Mr. DeHart, seconded by Mr. Ford, unanimously carried, the Board approved and accepted the lowest bid received, meeting all specifications, for roof repairs, in response to Hurricane Ida, at Acadian and Legion Park Elementary Schools from Edward J. Laperouse Metal Works, 1204 Lafayette Street, Houma, LA 70361, in the amount of \$557,209.95, and further, authorized the Board President to sign all necessary documents pertaining thereto.

Motion of Mr. DeHart, seconded by Mrs. Benoit, unanimously carried, the Board approved and accepted the lowest bid received, meeting all specifications, for site repairs, in response to Hurricane Ida, at School for Exceptional Children (SEC) from Automatic Access Gates, LLC., 8468 Paris Avenue, Baton Rouge, LA 70814, in the amount of \$84,000.00, and further, authorized the Board President to sign all necessary documents pertaining thereto.

Mr. LaGarde entered the meeting at this time and was present for the remainder of the proceedings.

Agenda Item 6. A. (3) Consideration of Approval of Bid received for HVAC Replacement/Upgrade Project at H. L. Bourgeois High School was withdrawn from tonight's agenda.

Motion of Mr. Ford, seconded by Mr. DeHart, unanimously carried, the Board voted to go into executive session, at this time (5:06 P.M.), to discuss the parent appeal for Student #0155700.

Motion of Mr. Ford, seconded by Mr. DeHart, unanimously carried, the Board reconvened in special session (6:05 P.M.) with all members present.

A motion offered by Mr. Ford to allow Student #0155700 to return to the base school at the beginning of the 2023-2024 school session, subject to signing a contract, and with the stipulation that said student would have monthly visits with a Terrebonne Parish counselor, for a report back to the Board prior to the start of the 2023-2024 school session, failed to carry due to lack of a second.

Motion of Mr. Hamner, seconded by Dr. Trahan, with the exception of Mr. Ford who objected, the Board voted to uphold the decision of the staff as it pertained to Parent Appeal for Student #0155700.

Motion of Mr. Hamner, seconded by Mrs. Benoit, unanimously carried, the Board voted to adjourn its meeting **(6:10 P.M.)**.
